

Angola acceded to the UN Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children in 2014. The current legislation on trafficking in persons in Angola–Articles 178, 190, and 196 of the Penal Code – covers all forms of trafficking indicated in the Protocol.¹






Number of persons convicted for trafficking in persons, by citizenship, 2017-2020*




Number of victims of trafficking in persons, by form of exploitation, 2017-2020*

Number of victims of trafficking in persons, by citizenship, 2017-2020*







Number of persons investigated for trafficking in persons for the purpose of sexual exploitation and forced labour, 2016–2019



Number of persons prosecuted for trafficking in persons, by sex, 2016 –2019





- Botswana -

Botswana ratified the UN Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children in 2002. The current legislation on trafficking in persons in Botswana³ – Section 9 of the Anti-Human Trafficking Act – covers all forms of trafficking indicated in the Protocol. Additionally, Article 114 of the Children's Act addresses child abduction and child trafficking.







- Cabo Verde -

Cabo Verde ratified the UN Trafficking in Persons Protocol in 2004. The current legislation criminalises trafficking in persons for the purpose of forced labour and sexual exploitation under Article 171 and 271a of the 2015 Criminal Code⁴.

In the 2019/2020 judicial year, no new cases of trafficking in persons were registered, and 11 cases carried over from the previous judicial year remained pending.

- Central African Republic -

The Central African Republic acceded to the UN Protocol on Trafficking in Persons in 2006. The current legislation on trafficking in persons in the Central African Republic - Article 151 of the Penal Code⁵ - covers all forms of trafficking indicated in the UN Trafficking in Persons Protocol.


Between February 2021 to June 2022, armed groups were implicated in 457 incidents of conflict-related sexual violence. Other perpetrators of conflict-related violence were national defence forces, bilaterally deployed and other security personnel.



Number of reported victims of conflict-related sexual violence (mostly rape), by sex, 15 October 2019 – 1 June 2022*




Number of children separated/released from armed groups or self-demobilised, Oct 2017 – Aug 2021



- Chad -

Legal overview

Chad acceded to the UN Trafficking in Persons Protocol in 2009. The legislation on trafficking in persons in Chad - Articles 330 and 331 of the Criminal Code - cover all forms of exploitation indicated in the UN Trafficking in Persons Protocol. Trafficking in persons, including sexual and labor exploitation, was officially criminalized in Chad in 2018 by Law 006/PR/18.

Between 2019 and 2020, the International Organization for Migration (IOM) assisted over 330 victims of trafficking in persons in Chad.

- Democratic Republic of Congo -

The Democratic Republic of Congo acceded to the UN Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children in 2005. The current legislation on trafficking in persons in the Democratic Republic of Congo criminalizes the worst forms of child labour (Section 6 of the Labour Code), the enrolment of children under 18 years of age in armed forces (Act No. 09/001 of 2009), and child marriage (Family Code of 2016). In addition, the Sexual Violence Law of 2006 criminalizes and prosecutes child trafficking for sexual exploitation.

Victims

Between 2019 and 2020, the United Nations Joint Human Rights Office documented the abduction of 508 civilians (304 men, 116 children and 88 women) during attacks. The victims of abduction were frequently used to transport looted goods.



In 2020, 460 children (307 boys and 153 girls) were abducted. Children were abducted for purposes of recruitment (273), sexual violence (88) and ransom (4) and for unknown reasons (95).

In 2020, the United Nations verified the recruitment and use of 788 children (687 male children and 101 female children), all of whom were recruited, used and separated in the same year. In addition, the recruitment and use of 1,164 children (747 boys, 417 girls) by armed groups were verified at a later date. In a small number of cases (2 per cent), children who had escaped or were released from armed groups were rerecruited by the same or different armed groups, sometimes within days of family reunification.

Between 2018 and early 2020, 331 newly recruited girls were subjected to rape, sexual slavery or forced marriage during their association with armed groups.

Between 2018 and 2020, the number of children used as combatants decreased. While in 2018, 794 children were used in active combat, in 2019, there were only 342 children used in active combat and in 2020, 240 children. Armed groups were found to employ between 35 and 55 per cent of all the children associated with their forces as combatants.

Children were also used in a variety of supporting roles, including as bodyguards, tax and food collectors, porters, cooks, mine labourers, herders, spies and sexual slaves or "wives". In 2020, 456 children were recorded to have served in support roles after recruitment.

Between 2018 and 2020, the vast majority of newly recruited children in armed conflicts were of Congolese (DRC) nationality. Other nationalities included children from Rwanda (6), Burundi (6) and Uganda (5).

- Eswatini -

Eswatini ratified the UN Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children in 2012. The current legislation on trafficking in persons in Eswatini – Article 12 of the People Trafficking and People Smuggling (Prohibition) Act – covers all forms of trafficking indicated in the Protocol.

Investigations and suspects

Between 2019 and 2020, eight cases of trafficking in persons were recorded. Ten offenders were investigated, prosecuted and/or convicted for trafficking in persons and related offences, among them six were men and four women. Less than five offenders currently under trial are public officials.

Between 2019 and 2020, seven offenders arrested for trafficking in persons were in the prosecution stage of their trial. During this period, three offenders were convicted of trafficking in persons offences.

Victims

Between 2019 and 2020, national authorities identified nine girls and less than five boys as victims of trafficking in persons in Eswatini. The main forms of exploitation recorded in trafficking in persons cases were forced labour and sexual exploitation.

From 2019-2020, less than five girls were trafficked to Eswatini from South Africa and Mozambique respectively.

- Gambia -

Gambia ratified the UN Trafficking Protocol in 2003. The current legislation on trafficking in persons in Gambia – Article 28 of the Trafficking in Persons Act⁶ – covers all forms of trafficking indicated in the UN Trafficking in Persons Protocol.

Investigations and suspects

In 2019, 12 cases of trafficking in persons were investigated by law enforcement authorities. Additionally, three prosecutions of trafficking in persons commenced in 2019. No convictions for trafficking in persons and related offences were reported in 2019.

Victims

In 2019, 21 persons were identified as victims of trafficking in persons in Gambia, all of them were women and most of them had been trafficked for the purpose of sexual exploitation.

In 2019, six Gambian victims were repatriated from Lebanon and Kuwait. National authorities report that adult victims of Gambian nationality were identified in Lebanon, Kuwait, Egypt and Oman. Gambian victims were mostly trafficked for the purpose of domestic servitude.

Ten Sierra Leonians victims were repatriated from Gambia in 2019. National authorities also identified victims of trafficking in persons from Nigeria (aldults and children). Most victims were trafficked for the puporse of sexual exploitation.

- Kenya -

Kenya acceded to the UN Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children in 2003. The current legislation on trafficking in persons in Kenya - Article 3 of the Counter Trafficking in Persons Act⁷- covers all forms of trafficking indicated in the UN Trafficking in Persons Protocol. In the Kenyan legislation, the crime of trafficking for sexual exploitation includes also offences prosecuted under the Sexual Offence Act of 2006, such as child prostitution and child sex tourism. Furthermore, the Counter-Trafficking in Persons Act of 2010 includes removal of body parts in addition to organs as form of trafficking.

Investigations and suspects

The Judiciary reported a total of 18 trafficking in persons cases filed between 2018 and 2021, of which nine were resolved.

Between 2017 - 2020, 35 were convicted of trafficking in persons, among them 23 were men and 12 women. Twenty persons were convicted of trafficking in persons for the purpose of sexual exploitation and 12 persons of trafficking in persons for the purpose of forced labour.

The Judiciary of Kenya reported that 28 Kenyans and seven Tanzanians were convicted of trafficking in persons between 2017-2020.


Lesotho ratified the UN Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children in 2003. The current legislation on trafficking in persons in Lesotho – Article 5 of the Anti-Trafficking in Persons Act – covers all forms of trafficking indicated in the Protocol.⁸

Investigations and suspects

Between 2017 and 2020, there were seven cases of trafficking in persons recorded. In the same reporting period, 26 cases were prosecuted for trafficking in persons. Between 2017 and 2020, eight males and less than five females were identified as traffickers.



- Liberia -

Liberia acceded to the UN Trafficking Protocol in 2004. The Act to Ban Trafficking in Persons, approved in Liberia in 2005, covers all forms of trafficking indicated in the UN Trafficking in Persons Protocol. In addition, child trafficking is criminalized and prosecuted under the Child Law of Liberia.


Number of cases of trafficking in persons recorded, 2018 - 2022*



Number of cases of trafficking in persons adjudicated with a conviction, 2018 - 2022*
























Number of perpetrators, by age and form of exploitation, 2019-2020*










Number of victims of trafficking in persons, by citizenship, 2019-2020

Number of foreign victims of trafficking in persons, by citizenship, IOM-NIGER, 2019-2020







Number of cases of trafficking in person, by form of exploitation, 2020






Number of persons brought into formal contact with the police and/or criminal justice system because they have been suspected of or arrested for trafficking in persons, by sex, 2014-2020

Number of persons convicted of trafficking in persons, 2014 – 2020





Number of victims of trafficking in persons detected, by age and sex, 2014 - 2020




Number of victims of trafficking in persons detected, by form of exploitation, 2017-2020



Number of victims of trafficking in persons, by form of exploitation, 2020




Number of victims of trafficking in persons, by sex and form of exploitation, 2020



Countries from which identified victims were repatriated, 2020 (tot: 78)







Number of trafficking in persons cases filed from 2018 to 2022







Number of grave violations committed against children, by type of offender, between 14 December 2019 and 13 May 2022





Types of grave violations committed against children between August 2018 and August 2020









Number of cases of trafficking in persons, 2018-2021







Number of cases taken to court, by status, 2020





Number of persons charged to court and convicted of trafficking in persons, 2017-2020





Number of victims of trafficking in persons registered, by form of exploitation and type of trafficking, 2020*







Number of Ugandan victims of trafficking in persons registered, by destination country, 2020




